Sir,

According to the decision of the meeting of the Board's Executive Committee dated 11.4.2008 on the registration of the new school from June 2008, it is inform you that regarding to the Secondary Education and Higher Secondary Education Act, 1972 (Gujarat Act No. 18, 1973 and Gujarat Act No. 14, 2002) and the Secondary Education Regulations, 1974 enacted thereto, and in accordance with the provisions of the Government resolutions and board circulars and the rules and regulations, your above mentioned school, Om band mark high school, post Mota chiloda, Dist. Gandhinagar, will be enrolled as a new school with condition for not taking permanent grant from June 2008. And your school is allowed to continue to the first one in grade eight. The medium of language in your school will be English. You must comply with the following conditions. Whenever there is a breach of the condition, the Board may cancel

the registration of your school by doing procedure under the provision 9(a) of Regulation.

Condition regarding Registration:-

1) The Board should ensure that the school's governing body is competent and reliable and that its administration is governed by a properly designed governing body and that it is financially sound.

2) Board officials or persons authorized by the Board and inspectors or officers of the Education Department shall be allowed to inspect the schools.

3) The school should have the necessary facilities, building, furniture, laboratory, equipment, stationery and other materials as per the regulations and the standards specified in the circulars made by the Board and should be appointed competent academic and non-academic staff according to the qualifications specified in the Regulations. In addition, the school should provide adequate health facilities for the students.

a) If there is a Northern basic school, then the suggested industry education will be

provided in the framework. Provision shall be made for land, water, workshop, industry etc. in accordance with industry as per the Rules.

b) The hostel will have to be managed by the North Basic School.

4) The board should ensure that the education provided in the school is satisfactory in all ways.

5) The school must use only the government-approved syllabus and the text books which is approved by the government time to time.

6) According to the stipulated conditions, students can be admitted in different standards.

7) In order to upgrade a student from one standard to the higher standard, the student should be promoted according to the test criteria set by the board.

8) The rate of education fees and the salary standards of the academic and non-academic staffs should be according to the government approve.

9) The registers and records prescribed by the Board shall be prepared and maintained

with the necessary details within the timeframe.

10) Records, statistical sheets and certificates provided by the school principal or administrators should be trusted.

11) The Board should ensure that the school staff and students are compliant with the disciplinary rules set by the Board from time to time.


12) The governing body must ensure that no invalid school or class or tuition class is operating in the school premises.

13) Do not prepare and send the same candidate again (second time), who has passed the examinations taken by the board, for the same examination.

14) The school cannot refuse admission to any student on the basis of any religion, ethnicity, caste, language or any such reason.

15) The school cannot start new standards or additional or reduce classes in the school without prior permission from the Board or the District Education Officer authorized by the Board.

16) For more information on staff recruitment and grants, the guidance will be taken from your district education officer and need to implement accordingly.

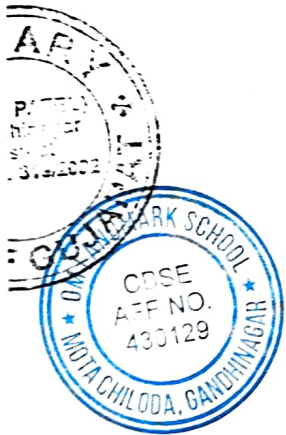
17) In the two month of the commencement of school, the staff profile of teachers with their educational qualifications will be submitted to the District Education Officer along with all grounds for approval.


18) The school has to report the Board and District education officer regarding the arrangement of appropriate building and other physical facilities to the school within one month of this order.

19) The school has to withdraw money from the school account and pay the required salary to all the School staff for every month on regular basis as per government norms.

20) All school records should be available to the principal in the school office.

21) If the certificates / Base have been obtained from the University / Institute outside the state of Gujarat, than the verification of such certificates / base should be done by the School board by

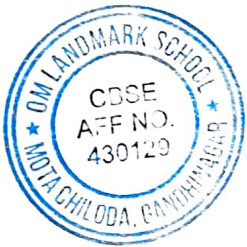

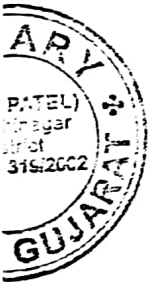

have to make all security arrangements
including fire safety.

23) The school has to abide the terms
stated in Government order no.
BMS/1093/1322/Chh dated 3.7.93.

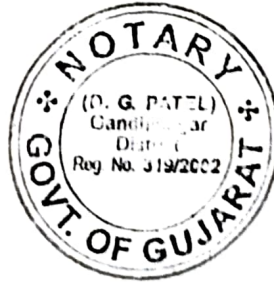
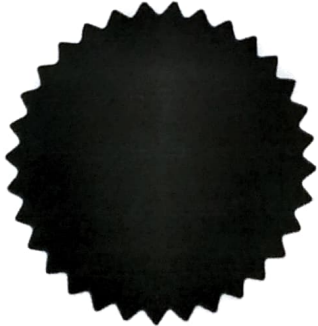
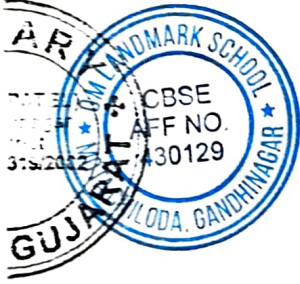
